

The GCA's talented, hard-working staff members are led by the chief operating officer. This small group works closely with volunteer leaders to provide GCA clubs with the resources they need.


#### **Headquarters**

#### Zone I

Located in Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont. 18 clubs and 1,400 club members.

#### Zone II


Located in Connecticut and Rhode Island. 20 clubs and 1,800 club members.

#### Zone III

Located in New York. 23 clubs and 1,800 club members

#### **Zone IV**

Located in New Jersey. 12 clubs and 875 club members.



#### Zone V

Located in Delaware and Pennsylvania. 14 clubs and 1,100 club members.

#### Zone VI

Located in Maryland and Washington, D.C. 13 clubs and 700 club members.

#### **Zone VII**

Located in Kentucky, North Carolina, Virginia, and West Virginia, 18 clubs and 1,400 club members.

#### **Zone VIII**

Located in Alabama, Florida, Georgia, and South Carolina. 16 clubs and 1,285 club members.

#### **Zone IX**

Located in Arkansas, Louisiana, Mississippi, Tennessee, and Texas. 20 clubs and 2,600 club members.

#### **Zone X**

Located in Indiana, Michigan, and Ohio. 11 clubs and 1,200 club members.

#### Zone XI

Located in Illinois, Iowa, Minnesota, Missouri, Nebraska, and Wisconsin. 18 clubs and 1,700 club members.

#### **Zone XII**

Located in Arizona, California, Colorado, Hawaii, New Mexico, Oregon, and Washington. 18 clubs and 2,100 club members.

### Committees

These committee members are ready to help you at any time.

#### Admissions\*

This committee is responsible for evaluating membership proposals for new clubs, GCA honorary members, and courtesy clubs for admission into our organization. admissions@gcamerica.org

#### **Archives**

Over one hundred years of the GCA's history are stored in the archives. Help is available to you for organizing your own club's archives. archives@gcamerica.org

#### **Audit**

This committee reviews the annual audit of the GCA and makes recommendations to the Executive Board.

#### Awards\*

The GCA is committed to honoring both club members and community leaders whose efforts support the purpose of our organization. From national to zone to club, there are medals, awards, and commendations for your club to present annually. <code>awards@gcamerica.org</code>

#### **Board of Associates\***

Individuals who have formerly served as officers, zone directors, directors, zone chairmen, GCA committee chairmen, or chairmen or co-chairmen of the annual meeting of the GCA automatically become members of the Board of Associates (BOA), which is a lifetime membership. This committee engages those BOA members who are interested in remaining involved, and provides a natural leadership platform for the On the Road with the GCA events and other zone-related opportunities.

#### **Bulletin\***

Check your mailbox four times a year for your issues of the *Bulletin*. You'll discover excellent articles about all areas of focus within the GCA, plus stories about the accomplishments of clubs across the country. You can even have it delivered to your inbox. *bulletin@gcamerica.org* 

#### Communications\*

This committee oversees the content of the GCA's website and social media presence. It also produces *eNews*, a monthly newsletter sent to all GCA club members with email addresses. #### Conservation\*

This committee will keep you well-informed about current conservation issues and what you can do in your zone or club. It produces position papers jointly with the NAL Committee on topics of vital importance to the GCA. For the first time this year, the Conservation Study Conference will be open to club member delegates as space allows. Check out *ConWatch*, the committee's quarterly magazine, online or have it sent to your inbox. #### **Finance**

This committee oversees the financial well-being of the GCA. It prepares the annual budget and monitors expenses. The GCA treasurer chairs the committee, and committee members serve as liaisons to GCA committees. *finance@gcamerica.org* 

#### Floral Design\*

This committee stimulates interest and educates all members in the art of floral design. It also provides guidelines and resources for club floral design programs and workshops, and sources for floral design materials. #### Flower Show\*

Flower shows exhibit beauty, share information, broaden knowledge, and underscore the importance of good environmental stewardship. Pulling them together can seem daunting. The committee provides encouragement, resources, administrative support, and guidelines on every aspect of putting on an amazing show. flowershow@gcamerica.org

#### Founders Fund\*

Since 1934, the GCA's Founders Fund has provided monetary awards to projects proposed by GCA member clubs. Today, the GCA awards a total of \$50,000 annually to three projects selected by the committee and presented for a vote by all GCA club members. foundersfund@gcamerica.org

#### **Garden History & Design\***

In partnership with the Smithsonian Institution, GCA clubs document gardens from all twelve zones to add to the GCA's distinguished collection in the *Archives of American Gardens*. The committee provides guidance and support for this important initiative, as well as an array of interesting resources about garden design on its landing page. *GHandD@gcamerica.org* 

#### Historian

The historian is available to help you write your club's history. Check the historian's landing page for examples of recent club histories and useful tips for recording the annals of your club, including conducting oral histories. historian@gcamerica.org

#### Horticulture\*

Depend on this committee to inspire a love of both plants and gardening. Horticulture's landing page contains a wealth of information, including its online newsletter, *The Real Dirt* — or have it delivered right to your inbox. The committee organizes the Shirley Meneice Horticulture Conference. In collaboration with the Conservation Committee, the committee administers the important Partners for Plants program, and oversees the annual selection of the Freeman Medal. #### Hospitality

#### Library

The GCA's Rare Book Collection is housed at the New York Botanical Garden. This collection is readily available to scholars, and clubs may arrange to see highlights of the collection by contacting HQ. #### National Affairs & Legislation\*

Attend the annual National Affairs & Legislation Conference in Washington, D.C. at least once. This powerful experience will forever change the way you think of the GCA. #### Nominating\*

This committee works to shape the dynamic leadership of the GCA. ave you been searching for new ways to strengthen important community ties and create new partnerships? The GCA has meaningful ways to help you. Here are just a few ideas.

#### **Awards**

Recognizing good work is fun and powerful, either through monetary awards or public acknowledgment — or both.

**Elizabeth Abernathy Hull Award:** This monetary award recognizes contributions to the environmental education of children 16 years of age and younger. Your Scholarship Committee zone rep can help you honor a deserving teacher or volunteer.

**Zone Commendation:** Give recognition to a deserving person or organization, who is not a member of a GCA club, but has led a significant community project in alignment with the GCA's purpose. Contact your Awards Committee zone rep for help.

**GCA Medal:** Would you like to honor a person who has made a national impact in a field related to the GCA's purpose? These inspiring medals are presented at the GCA annual meeting. Ask your Awards Committee zone rep for guidance.

#### **GCA Honorary Members**

Is there an outstanding person in your community whom you would like to honor for exceptional contributions in a field compatible with the GCA's purpose? To see whether this person is eligible to become a GCA honorary member, talk to your Admissions Committee zone rep.



#### **Grants**

Apply for monetary awards to improve and restore your community.

**Founders Fund:** The GCA awards a total of \$50,000 annually to three projects proposed by local clubs and selected by the committee and presented for a vote by all GCA club members.

Partners for Plants: Is your club interested in habitat restoration, such as protecting endangered plants or removing invasive species? The GCA's Conservation and Horticulture committees can supply funds to help you partner with land managers on federal, state, local, or other significant public lands.

**Restoration Initiative:** The GCA offers grants for public landscape restoration and conservation projects in communities devastated by natural disasters.



**The GCA Annual Meeting** is held in the spring, and each of the member clubs sends two participants. This educational meeting showcases the host city and offers tours, speakers, workshops, a flower show, demonstrations, informative business meetings, an inspiring awards dinner, and opportunities to exchange ideas with fellow meeting attendees.

**The Shirley Meneice Horticulture Conference,** organized by the Horticulture Committee, is held every fall at an important botanical center. Attendees hear nationally recognized speakers, learn about propagation, and are privy to new horticultural tips. All clubs are encouraged to send delegates, so if you love horticulture, volunteer to go.

**The National Affairs & Legislation Conference,** organized by the NAL Committee, is held annually in February in Washington, DC. 300 GCA club members attend and learn about environmental initiatives relating to the GCA's purpose. All NAL attendees visit their congressional representatives' offices to advocate for matters of importance to their communities. This is just one example of the GCA's organizational power.

**The Conservation Study Conference** is open to club member delegates for the first time in 2019. Club members who have never served on the Conservation Committee or attended the NAL Conference will have registration priority. If you are passionate about conservation, this is a wonderful opportunity to learn more about environmental issues of importance to the GCA.



**Zone Meetings** provide a forum within each zone (either annually or biannually) where club presidents and delegates, zone reps, and GCA leaders share objectives, develop leadership skills, and learn about GCA resources. These meetings are hosted by clubs in the zone. They celebrate the autonomy of the clubs, while focusing on the benefits of GCA membership. **Zone Mini-meetings** are official GCA meetings, too. Although smaller in size and shorter in length, they may alternate in years with a full zone meeting.

**Presidents Councils,** arranged by the zone chairmen in each zone, serve as a forum for exchanging ideas among the club presidents. This meeting may be the primary gathering (instead of a zone mini-meeting) every other year in zones holding biennial zone meetings.

**Zone Rep Meetings** are held in zones where clubs are close geographically. They provide an opportunity for national committee reps to meet with their club counterparts for educational and informational exchanges.


**Area Committee Meetings** in Boston, New Jersey, New York, and Philadelphia help to maximize the combined resources and talents of all area member clubs by collaborating on major projects.

**Floral Design Workshops** are beginner and intermediate-level workshops designed to build skills and create new generations of flower arrangers, exhibitors, and floral design judges.



**Photography Workshops** are designed to educate all GCA club members regardless of expertise and experience. In addition to these workshops, Photography 101 is a free series of video tutorials aimed at the novice. Use them on their own or as a club program.





**Judging Workshops** help maintain judging standards and are part of the continuing education process of the GCA Judging Program. These workshops are intended to expose GCA Judges to new trends and practices.

**Floral Design Study Group Workshops,** organized by the Floral Design Committee, are workshops designed for experienced flower arrangers and taught by a cutting edge, often international, floral designer.

**Photography Study Groups Workshops** organized by the Photography Committee, are worshops designed for more experienced photographers and taught by experts in the field.

**On the Road with the GCA** are educational events open to all club members (and spouses). They are informative excursions planned in locations across the country. It's a great opportunity to experience the GCA first-hand, and it is a ready-made club field trip.
